


Marj's Kitchen will close for the holiday season on Friday, December 21st at 1:00 pm. It will re-open for business on Wednesday, January 2, 2002.

CRTC License Hearings

As you know the CRTC hearings for new licenses to serve Toronto, Hamilton and Kitchener have just concluded. To say the least it was an interesting experience to be a spectator in the audience and listen to the 5 applicants slamming their competitors for their shortcomings and at the same time promising to do more then anyone else. Someone said it reminded them of a "WWF Rumble" in business attire.

It is very difficult if not impossible to predict what the Commission will do, having said that here are my thoughts on the hearing.

The best-written presentation belonged to Alliance Atlantis who applied for GTTV, a Toronto station with re-broads in KW and Hamilton. Their approach was similar to MYTV in that their news focus would be the GTA. The AA proposal was referred to by CHUM as warmed over CITY TV and they dropped the ball during the oral presentation when they couldn't describe the new innovative Canadian Programming they were talking about.

The best appearing presentation was the Craig Family. They proposed a Toronto station with a re-broad in Hamilton. They were light on news, (4.5 hours a week at alternative time), but said they would produce 14 hours a week of variety and other under-served categories. They had an excellent panel including former Toronto Mayor David Crombie. They also proposed to serve the 3rd generation ethnic market with programming tailored to that segment in English. They have fallen short of their commitments in Alberta and stumbled on what foreign programming they would acquire.

Global's presentation for "Proudly Canadian" was embarrassing to watch. They tried to "suck and blow" at the same time by telling the CRTC there wasn't any room for another station but if there is give it to us.

Rogers presented an excellent case for a 2nd multilingual station and even suggested that the CRTC should license 2 stations, them and one of the other applicants. They had lots of support from the ethnic communities.

Torstar brought out all the big guns for the hearing and were pushing hard for the license. They were challenged on the quality of their proposed programming and their commitment to be all "Canadian Content". They proposed a schedule that was 93.5 % Canadian but asked for a license condition of only 80%. In the end, after much prodding, they agreed to 85% Canadian.

I think the Commission would like to grant a license for at least the Toronto market even though CTV, Global, CHUM, Standard Radio and Telemedia all said the market would not support another station. In my opinion the leading contenders are Torstar and Rogers.

While Torstar got pushed around on some areas I thought the CRTC took it easy on them. Their pitch uses all the right buzzwords; the question is will the CRTC scratch deep enough into the written application to see that there really isn't anything of value there for the KW market.

The Rogers application also has a lot of resonance with the Commission as it promises to serve the large ethnic market in the Toronto area, and they suggested that two licenses should be given.

My guess, and it really is a guess, is that either Rogers or Torstar will get a Toronto only license but we won't know for sure till the CRTC gives their decision, which should be in March of 2002.


